# **Coronavirus sprint becomes** a marathon

As the country's first dialysis provider treating a patient known to have COVID-19, Northwest Kidney Centers worked closely with the Centers for Disease Control and Prevention (CDC) and Public Health – Seattle & King County.

We contributed experience and expertise as the agencies developed clinical measures for safe dialysis during the pandemic; our clinical leaders also wrote journal articles, spoke at online seminars and were interviewed in public media including The New York Times.

Our guiding principles: 1) Provide safe dialysis in the outpatient setting to all patients, including those with COVID-19, so long as they aren't so sick that hospitalization is required. 2) Follow the science. 3) Provide leadership to patients and their families, staff and the community.

#### Our community rises to the challenge of COVID-19

#### **Necessity** is the mother of invention

Coping with COVID-19 has meant finding new and creative ways to get medical supplies. One example is Northwest Kidney Centers 2020 Private Reserve, hand sanitizer custom formulated for us by a compounding pharmacy. We expect to distribute more than 3,000 bottles of Private Reserve to staff, patients and transportation drivers.

Because of changes in regulations due to the pandemic, physicians now can see patients via telehealth technology. This allows doctors to be more available and flexible to "meet" with patients at dialysis.

#### Community delivers masks and more

When medical grade face masks were in short supply, craftspeople in the community donated more than 5,550 handsewn masks, in all styles, colors and sizes. Each of our clinics gives them to patients, staff, families and transportation drivers.

Several community partners, vendors and medical staff provided pocket-size bottles of hand sanitizer and medical grade face masks. A local nonprofit organization donated 500 grocery store gift cards for patients in need.

We are grateful for every donated face shield created on a 3D printer, every bagel and cookie, every bouquet of flowers and every kind word.

# CARES Act may impact your charitable giving

The Coronavirus Aid, Relief and Economic Security (CARES) Act enacted on March 27 includes temporary and permanent changes to the tax code that may impact your charitable giving. These include:

- New \$300 above-the-line charitable contribution deduction
- Suspension of required minimum distributions in 2020
- Temporary repeal of adjusted gross income (AGI) limit for gifts of cash

# HopeBuilders funds charity care and Eastside expansion

# **COVID-19** makes its mark on kidney research

COVID-19 has brought opportunities and challenges to scientific understanding of kidney conditions.

"We now know that kidney failure can be a side effect of COVID-19," points out Dr. Jonathan Himmelfarb, director of the Kidney Research Institute, a collaboration between Northwest Kidney Centers and UW Medicine. The KRI is working to understand how the coronavirus affects kidney function.

The COVID-19 pandemic is adding urgency to work on new mobile, user-friendly dialysis technology. And KRI scientists are taking a close look at COVID-19's impact on transplant recipients.

Meanwhile, COVID-19 has stalled some ongoing research studies, primarily due to social distancing. KRI investigators are not able to visit Northwest Kidney Centers patients in the dialysis clinic. Nearly all research labs are closed or allowing just one person to enter per day.

Some investigators are able to work from home to analyze data collected previously or to write grant proposals. Dr. Himmelfarb anticipates current studies will be able to resume soon, and new studies are being planned to start in the fall.



Kidney Research Institute scientists like Dr. Beno Freedman benefit from Northwest Kidney Centers support of research. By making creative use of new technology to reveal and understand biology and diseases, the work from his lab is leading toward novel treatments for kidney disease in precision medicine interventions, gene therapy and regenerative medicine.

Dr. Freedman's lab uses human kidney structures or "organoids" as surrogates for patients, which allows therapies to be developed more quickly and safely. In the future this technology may make it possible to grow grafts from a person's own body that can help regenerate the kidney.




